APHA Briefing Note 30/25

Changes to the List of Approved Disinfectants

Date issued: 06 August 2025

Purpose

1. To inform Official Veterinarians (OVs) and, where appropriate Approved Tuberculin Testers (ATTs), of relevant changes to the list of approved disinfectants.

Background

2. A Defra approved disinfectant scheme (administered by APHA on behalf of all the GB administrations) operates to assess and record those disinfectants that have met certain criteria resulting in demonstrated efficacy in specific circumstances. Disinfectants approved under this scheme appear on the [approved disinfectant list](#) under different notifiable disease and general orders.
3. APHA operates a robust check test programme of all disinfectants that appear on the approved disinfectant list to ensure continuing efficacy. A disinfectant that does not pass a check test for a specific order will be suspended from the approved disinfectant list for that order. Disinfectant approval may also be suspended for other reasons.
4. When an approval is suspended, use of the suspended product in statutory disease control situations for the relevant order must cease, and an alternative approved disinfectant under the relevant order should be selected for use from the approved disinfectant list.
5. Notice of changes are published on the [approved disinfectants list](#) in the public domain but this briefing note is to rapidly bring significant changes to the attention of OVs and ATTs who are unlikely to be looking at the approved list on a daily basis.

What's changing?

6. On Friday 01 August 2025, the following disinfectant was reinstated on the Defra approved disinfectant list:

Virkon S under Diseases of Poultry and the Avian Influenza of Avian Origin in Mammals Orders (DoP, AI & IAOM).

7. Use of the above disinfectant for the disease orders mentioned is reinstated with immediate effect with a new dilution rate. Please refer to the Defra approved disinfectant list for details of the new dilution rate.

Action

8. OVs and ATTs are advised to check the [approved disinfectants list](#) to inform their choice of disinfectant, ensuring that it is approved for use under the relevant Order(s) and that it is being used at the appropriate dilution rate for the relevant Order(s).
9. OVs and ATTs are requested to cascade the content of this Briefing Note to their customers and other interested parties.
10. Briefing Notes are only sent regarding certain disinfectants that APHA are aware are used in carrying out OV and ATT duties. It remains the responsibility of OVs and ATTs to ensure that, at all times, the disinfectant they are using is approved for the purpose for which they are using it.
